What are Australia's New inverter installation rules?

The upcoming inverter installation rules represent a major shift in the regulatory landscape for distributed energy systems in Australia. With a focus on safety, flexibility, and grid stability, the new guidelines encourage responsible growth of solar and battery technology.

What are the new Australian standards for solar inverters?

As a solar installation professional, it's your legal obligation to be aware of and to comply with these new industry requirements which came into effect on 18 December 2021. AS/NZS 4777.2:2020 is the Australian Standard for inverters and applies to the grid connection of both solar PV and battery systems.

Are solar & battery inverters required in Australia?

Solar and battery inverters connecting to the Western Power grid must be installed with AS/NZS 4777.2:2020 'Australia Region B' settings. As a solar installation professional, it's your legal obligation to be aware of and to comply with these new industry requirements which came into effect on 18 December 2021.

Do I need a solar inverter in Victoria?

Solar and battery inverters in Victoria and all Eastern Australia must be installed with AS/NZS 4777.2:2020 Australia A settings. It is your legal obligation to be aware of and to comply with these new requirements.

How do I configure solar PV & battery inverter settings in Victoria?

To correctly configure solar PV and/or battery inverter settings in Victoria, simply: Select your country/region. Some manufacturers may have this pre-selected. Select the AS/NZS 4777.2:2020 Australia A setting. The naming of zones may differ between manufacturers but may appear as:

Are inverters AS/NZS 4777.2 compliant?

Installers must follow AS/NZS 4777.1 guidelines to ensure safe, compliant installations. Manufacturers must certifytheir inverters under AS/NZS 4777.2 to sell them in Australia or New Zealand. Operators benefit from standardized inverter behavior, making it easier to manage distributed energy resources.

If your inverter sees a grid voltage that is too high for too long, Australian Standards mandate it disconnects from the grid. Before the voltage is so high it disconnects, ...
