What is a base station in radio communications?

In radio communications, a base station is a wireless communications station installed at a fixed location and used to communicate as part of one of the following: a wireless telephone system such as cellular CDMA or GSM cell site. Base stations use RF power amplifiers (radio-frequency power amplifiers) to transmit and receive signals.

Which satellite stations are licensed under 47 CFR Part 97?

§ 25.109 Cross-reference. (a) Space and earth stations in the Amateur Satellite Serviceare licensed under 47 CFR part 97. (b) Ship earth stations in the Maritime Mobile-Satellite Service transmitting in the 1626.5-1646.5 MHz band are subject to licensing under 47 CFR part 80.

Do I need a station authorization?

§ 25.102 Station authorization required. (a) No person shall use or operate apparatus for the transmission of energy or communications or signals by space or earth stations except under, and in accordance with, an appropriate authorization granted by the Federal Communications Commission.

What are the different types of base stations?

In US licensing jargon,types of base stations include: A fixed station is a base station used in a system intended only to communicate with other base stations. A fixed station can also be radio link used to operate a distant base station by remote control.

What is a base station in a wireless network?

In the area of wireless computer networking, a base station is a radio receiver/transmitterthat serves as the hub of the local wireless network, and may also be the gateway between a wired network and the wireless network. It typically consists of a low-power transmitter and wireless router.

Can a WCS licensee operate a base station?
