What is the support structure of a wind turbine generator system?

The support structure of the wind turbine generator system including system foundation structureand vessel structure supporting the system foundation are to be designed in accordance with Subsection 3/2 of the ABS Requirements for Wind Assisted Propulsion System Installation.

How do I choose a wind power plant dynamic model?

Selection of appropriate model parameters requires consultation with inverter manufacturer and plant operator. Wind power plant dynamic modeling is an area of active research. As with any other model, the WECC generic wind power plant models will evolve based on industry experience and technology evolution.

What are the WECC generic models for wind power plants?

The WECC generic models for wind power plants are based on the following technical specifications: The models shall be non-proprietary and accessible to transmission planners and grid operators without the need for non-disclosure agreements.

How do I model a wind power plant?

In accordance with the WECC Wind Plant Power Flow Modeling Guide7, wind power plants must be represented by a simplified system consisting of one or more equivalent generators and unit transformers, equivalent collector system, substation transformer, and plant-level reactive support system, if present.

How does a wind energy developer decide on a regulatory structure?

Long before a wind energy developer begins generating the first megawatt of power, the developer must decide on a regulatory structure for the project and negotiate and execute transmission and interconnection agreements. This chapter presents a general discussion of these issues.

Which models are suitable for wind power plants?

Subject to some limitations, and with proper selection of model structure and parameters, the models are suitable for representation of wind power plants that use Type 1, Type 2, Type 3 or Type 4wind turbine generators. Explicit representation of the generation in the power flow model is required for all models.
