Can a lithium battery be mailed domestically?

For domestic mailings only, small consumer-type primary lithium cells or batteries (lithium metal or lithium alloy) like those used to power cameras and flashlights are mailable domestically under certain conditions.

Can a lithium battery be transported on a plane?

o Damaged, defective, or recalled lithium batteries are forbidden from air transport. See page 7 for information on DDR batteries. o These shipments are forbidden to be transported as cargo on passenger aircraft (column 9 of the HMT - 167; 172.101).

Can a battery be shipped by air?

Mirror road regulations. Not all battery types can be shipped by air. For example, lithium-ion batteries over a specific Watt-hour rating must be shipped by sea or road. Also, some airlines may have carrier-specific rules more stringent than IATA's baseline.

What are the requirements for packaging a lithium battery?

*The outer packaging must be a strong rigid outer package that is capable of withstanding a 1.2 meter drop test without damage to the cells or batteries, without shifting that would allow battery-to-battery contact, and without release of the contents of the package. o For packages with lithium cells or batteries contained in equipment:
