What are the fire and building codes for energy storage systems?

However, many designers and installers, especially those new to energy storage systems, are unfamiliar with the fire and building codes pertaining to battery installations. Another code-making body is the National Fire Protection Association (NFPA). Some states adopt the NFPA 1 Fire Code rather than the IFC.

Does NFPA 855 require explosion control?

NFPA 855 [*footnote 1], the Standard for the Installation of Stationary Energy Storage Systems, calls for explosion control in the form of either explosion prevention in accordance with NFPA 69 [*footnote 2] or deflagration venting in accordance with NFPA 68 [*footnote 3].

What is a battery energy storage system?

Battery Energy Storage Systems (BESS) represent a significant component supporting the shift towards a more sustainable and green energy future for the planet. BESS units can be employed in a variety of situations, ranging from temporary, standby and off-grid applications to larger, fixed installations.

Do I need a sprinkler system for a battery ESS?

A: Testing has shown that water is the most effective agent for cooling for a battery ESS. For this reason, a sprinkler system designed in accordance with NFPA 13, Standard for the Installation of Sprinkler Systems, is required by NFPA 855, Standard for the Installation of Energy Storage Systems.

Are there any problems with energy storage?

There have also been issues in the U.S. residential energy storage sector. For example, after five reported fires stemming from its RESU10 battery units, LG Chem issued product recalls in December of 2020 and again in August 2021. According to the Consumer Product Safety Commission, these fires resulted in property damage and one injury.

What are non-residential storage requirements?

For storage capacities that exceed these limits, non-residential requirements come into play (NFPA 855 Chapters 4-9). Fire detection, including smoke and heat alarms, vehicle impact protection with approved barriers, and ventilation requirements for chemistries that produce flammable gas during normal operation are addressed.
