

How many external power supplies are there in the EU?

In 2020, 1.7 billion external power supplies (EPS) were in use in the EU27, of which 75% for residential use, on average 6.5 units per EU household. They converted 48 TWh/a of electricity from the 220V mains to the input needed by the powered products.

Are external power supplies efficient?

The efficiency of external power supplies (EPS) has been a concern of power supply manufacturers and OEM's since California mandated the first efficiency requirements in 2004.

Does the EU require a Level V power supply?

The EU on the other hand continued to require Level V, but starting in 2013, the Joint Research Centre of the European Commission had released a voluntary standard defined in its Code of Conduct on Energy Efficiency of External Power Supplies version 5, often referred to as CoC v5 or just CoC.

Are external power supplies a legal requirement?

In 2020 it was finally scrapped and in its place the EU introduced the new Ecodesign 2019/1782 requirements for external power supplies, which is a legal requirement, not a voluntary one.

How to choose a portable power station in Europe?

Portability is a crucial factor when selecting a portable power station in Europe, as the weight and design directly influence how easily you can transport it. The weight of these units can vary significantly, with lightweight models around 25 pounds being much easier to carry compared to heavier options that exceed 100 pounds.

How much money will EU27 users save on external power supplies?

In 2020, due to Ecodesign measures, EU27 users saved EUR 0.9 billion on external power supplies. This is projected to increase to EUR 1.3 billion in 2030, a 16% saving. In 2030, the annual household expenses for EPS are projected to decrease from EUR 33 (without measures) to EUR 28.
