Which countries adopt voluntary and mandatory external power supply standards?

Since then, the US, European Union, Chinaand other countries adopted both voluntary and mandatory external power supply standards as part of energy conservation legislation. Table 1 shows a breakdown of some of the current voluntary and mandatory standards by region.

What percentage of power does a power supply take?

All specifications, both EU and US standards, are based on taking an average of 25%, 50%, 75% and 100% of the nominal output power.
