Can PV pay back its energy investment?

With energy paybacks of 1 to 4 years and assumed life expectancies of 30 years, 87% to 97% of the energy that PV systems generate won't be plagued by pollution, green-house gases, and depletion of resources. Based on models and real data, the idea that PV cannot pay back its energy investment is simply a myth.

Why is PV technology integrated with energy storage important?

Is energy storage a good investment?

The return of investment is an important metric about how attractive an investment may be. However this is an important note that energy storage usually does not generate electricity savings directly, but allows the transport or trading of electricity. This usually results in storage not having a high ROI like solar investments, for example.

What is storage NPV in terms of kWh?

The storage NPV in terms of kWh has to factor in degradation, round-trip efficiency, lifetime, and all the non-ideal factors of the battery. The combination of these factors is simply the storage discount rate. The financial NPV in financial terms has to include the storage NPV, inflation, rising energy prices, and cost of debt.

What is the storage NPV for a red battery?

The storage NPV for the red battery in terms of kWh delivered over 10 years results in a calculation of: 945kWh delivered from a battery designed for 100kWh per year. Mapping from yearly to daily -> $100\text{kWh} / 365 = 0.274\text{kWh}$ nominal delivering 945kWh over 10 years.
