Nevada: The state's Solar Easement and Rights Law prohibits any unreasonable ban or restriction on solar panels. New Jersey: Under state law, HOAs have limited power to restrict solar panel installations on residents' properties. New Mexico: The state's Solar Rights Act makes access to solar power a "property right."

Can HOAs ban solar panels?

Indiana: In Indiana, House Enrolled Act 1196 allows homeowners to petition HOAs attempting to deny installations. The state doesn't entirely prohibit HOAs from banning solar power installation, but there are only 10 reasons for a total ban. Louisiana: The state's HB 751 prohibits homeowners associations from banning solar panels.

How do I know if a solar panel installation is legal?

Check to determine whether the association's governing documents include any restrictions or requirements, including panel location, that could impact a solar panel installation. Then confirm if those restrictions or requirements conform with the current state law. These laws are changing rapidly, and many governing documents have not kept up.
