In April 2025,the U.S. administration implemented a series of tariffs affecting a broad range of imported goods,including critical components for solar energy systems. These tariffs,varying between 10% and 50% depending on the country of origin,have introduced new challenges for the solar industry,impacting both manufacturers and consumers.

What are the new solar tariffs?

These new tariffs announcements come on the heels of previous plans to roll out tariffs up to 3,521% on all four of the countries in Southeast Asia that supply the U.S. with the majority of its solar imports, making yet another change to the administration's trade policy.

Although the cost to install solar in the United States is higher than elsewhere in the developed world, the industry continues to grow in the U.S. The good news is that there has been significant investment in solar manufacturing in the U.S., so the industry is somewhat insulated from the impact of tariffs.

What are the reciprocal day tariffs affecting solar panels?
