What is Papua New Guinea customs tariff 1990 - 4 - 5?

Customs Tariff 1990 - 4 - 5. RATE OF EXPORT DUTY. (1) The export duty in respect of goods entered for export out of Papua New Guinea is the rate of duty specified in Column 3 (headed "Rate") of Schedule 2 opposite the Tariff Item number and description of the goods.

How are export duties charged in Papua New Guinea?

All export duties in respect of goods entered for export out of Papua New Guinea are charged, paid and collected in accordance with Section 5 of the Customs Tariff Act, as specified in column 3 of Schedule 2 and is subject to variation on export price change. Where no item appears in Schedule 2 the "rate of export shall be free";.

Tariffs are essentially taxes levied on goods when they cross international borders, designed to regulate import levels and protect domestic industries.

4. DUTIES OF CUSTOMS ON EXPORTS. Subject to the provisions of this Act, duties of customs, being export duties, are imposed in accordance with this Part on all goods exported from Papua New Guinea and shall be charged, collected and paid on all such goods accordingly.
