

What are the requirements for fire protection of energy storage systems?

The standard offers comprehensive criteria for the fire protection of energy storage system (ESS) installations based on the technology used, the setting where the technology is being installed, the size and separation of ESS installations, and the fire suppression and control systems in place.

What are the fire and building codes for energy storage systems?

However, many designers and installers, especially those new to energy storage systems, are unfamiliar with the fire and building codes pertaining to battery installations. Another code-making body is the National Fire Protection Association (NFPA). Some states adopt the NFPA 1 Fire Code rather than the IFC.

Is NFPA 855 a safety standard for energy storage?

The American Clean Power Association is pushing for greater safety standardization in the energy storage industry, guided by the National Fire Protection Association, and their under development NFPA 855 standard.

What are non-residential storage requirements?

For storage capacities that exceed these limits, non-residential requirements come into play (NFPA 855 Chapters 4-9). Fire detection, including smoke and heat alarms, vehicle impact protection with approved barriers, and ventilation requirements for chemistries that produce flammable gas during normal operation are addressed.

When should explosion prevention systems be installed?

If there are enough batteries in a room to create an explosive atmosphere, then explosion prevention systems or deflagration venting should be installed per NFPA 68, Standard on Explosion Protection by Deflagration Venting, and NFPA 69, Standard on Explosion Prevention Systems.

Are there any problems with energy storage?

There have also been issues in the U.S. residential energy storage sector. For example, after five reported fires stemming from its RESU10 battery units, LG Chem issued product recalls in December of 2020 and again in August 2021. According to the Consumer Product Safety Commission, these fires resulted in property damage and one injury.
